**IMPEXIA’S REPLY TO COMPLAINANTS’ MOTION  
TO STRIKE IMPEXIA’S OPPOSITION**

Respondent Impexia Inc. (“Impexia”), by its counsel, hereby opposes Complainants’ Motion to Strike Impexia’s Opposition. Impexia consulted with the Federal Maritime Commission’s (“FMC” or “Commission”) Office of the Secretary and confirmed that Your Honor’s March 6, 2014 Notice of Extension of Time to File Replies to Exceptions (the “Order”) applied to all Respondents—including Impexia. Accordingly, Impexia’s reply was timely filed with the Commission.

Impexia was prepared to file its own extension request. On March 4, 2014 Impexia consulted with Complainants’ counsel regarding whether Complainants would oppose an

extension to reply until March 26, 2014. Complainants confirmed that they would not oppose such a request. On March 6, 2014, prior to Impexia filing its extension request, Your Honor issued an Order extending the time for filing a reply to Complainants' exceptions from March 12, 2014 to March 26, 2014. *See* Order at 1. On March 7, 2014, Impexia called the Office of the Secretary to confirm that this Order applied to both Impexia and Barsan. The Office of the Secretary confirmed the Order applied to all Respondents, and that filing a separate request for extension was unnecessary. As such, Impexia timely filed its reply on March 26, 2014, in accordance with Your Honor's Order.

### **CONCLUSION**

For the foregoing reasons, Respondent Impexia respectfully requests that Complainants' Motion to Strike Impexia's Opposition be denied.
