
MOTION FOR VOLUNTARY DISMISSAL WITHOUT PREJUDICE

WHERE AS Complainant SBI International, Inc., (SBI) filed a Complaint with the Commission seeking adjudication as an informal proceeding pursuant to 46 C.F.R. Subpart S. SBI alleges that Respondent Mr. Howard Finkel c/o Cosco Container Lines Americas, (Cosco Lines) violated the Shipping Act of 1984 when it failed to deliver four (4) containers in China to the correct destination as stated in the original contract.




