FOURTH JOINT STATUS REPORT

Complainant Edaf Antillas, Inc. ("Edaf") and Respondents IFS International Forwarding, S.L., IFS Neutral Maritime Service, Inc. ("IFS") and Crowley Caribbean Logistics, LLC ("CCL") (collectively, "Parties") hereby submit this joint status report pursuant to the December 16, 2014 Amendment to Discovery Schedule.

The First Joint Status Report in this matter was filed August 11, 2014. The Second Joint Status Report in this matter was filed October 10, 2014. The Third Joint Status Report in this matter was filed December 15, 2014. A status report was filed January 9, 2015, while the parties were still discussing the schedule going forward.

With respect to discovery, the parties have conferred and the telephonic deposition of Edaf representative Carlos Matos is scheduled for 1000 a.m. on January 13, 2015. The telephonic deposition of Edaf's accountant Salvadore Lugo Cosme is scheduled for 1000 a.m. on January 14, 2015.

fact, appendices and brief to be filed February 23, 2015. Respondents' proposed findings of fact, appendices and briefs to be filed March 23, 2015. Any reply brief by Complainant to be filed April 6, 2015.

The Parties agree that an oral hearing is not necessary in this matter.

There are currently no other motions pending in this matter at this time.


