**JOINT STATUS REPORT AND  
JOINT MOTION TO TEMPORARILY ABATE DISCOVERY SCHEDULE**

Complainants Santa Fe Discount Cruise Parking Inc. d/b/a EZ Cruise Parking, Lighthouse Parking, Inc. and Sylvia Robledo d/b/a 81<sup>st</sup> Dolphin Parking and Respondents The Board of Trustees of the Galveston Wharves (“Board of Trustees”) and Galveston Port Facilities Corporation (“GPFC”) hereby submit this joint status report and proposed schedule for the completion of discovery pursuant to 46 C.F.R. § 502.201(h) and the Order Amending August 11, 2014 Discovery Schedule issued by Administrative Law Judge Guthrie on or about September 30, 2014. Additionally, Complainants and Respondents jointly request that the Discovery Schedule in this proceeding be temporarily abated for the reasons set out below.

**1. Status of this Action, Discovery, and any Pending Motions**

Since the Parties filed their previous Joint Status Report on September 26, 2014, the following events have occurred:

- A. On October 21, 2014, Respondents filed and served their Motion to Dismiss.
- B. On October 24, 2014, Complainants filed and served their Opposed Motion for Leave to File Amended Complaint.
- C. On October 30, 2014, Respondents filed and served their Response in Opposition to Complainants' Opposed Motion for Leave to File Amended Complaint.

The Motions set out above relate to modifications to Item 111 of its Tariff Circular No. 6 approved by the Board of Trustees at its meeting held on September 22, 2014. The specific changes are discussed generally in the parties' Joint Status Update submitted on September 26, 2014 and are attached to Respondents' Motion to Dismiss.

2. Agreements Between Parties Relating to Discovery and the Scheduling Order in this Proceeding

Until the Administrative Law Judge rules on the pending Motions set out above, the Parties request that the Scheduling Order in this case be temporarily abated. These rulings will determine what issues may or may not remain in dispute in this proceeding, and allow the parties to avoid incurring expenses associated with discovery, depositions and expert witnesses on issues that may subsequently be rendered moot by either ruling.
