STATUS REPORT

Complainant, Complainant, Ngobros and Company Nigeria Limited (“Complainant” or “NCNL”) (“Complainant “or “NCNL”), through its counsel, provides the following status report regarding the above-referenced matter:

1. On November 10, 2015, the Administrative Law Judge (“ALJ”) Erin M. Wirth issued an Initial Decision, which found that Oceane Cargo Link and Kingston AnsaH knowingly and willfully violated section 41102(c) of the Shipping Act, 46 U.S.C. § 41102 (c). The ALJ ordered that Oceane Cargo Link and Kingston AnsaH be found in violation of section 41102(c) of the Shipping Act. The ALJ further ordered that Oceane Cargo Link and Kingston AnsaH jointly and severally be ordered to pay Ngobros and Company Nigeria Limited reparations in the amount of \$162,266.04.

2. On November 24, 2015, the Commission issued a notice that, pursuant to 46 CFR § 502.227, the Commission has determined to review the decision in this proceeding.

3. On or about February 1, 2016, Respondent Kingston Ansah filed a Chapter 13 Bankruptcy Petition, United States Bankruptcy Court, Northern District of Georgia, Case number: 16-51822-a998.
