**JOINT MOTION TO HOLD CASE IN ABEYANCE**

World Imports Ltd, World Imports Chicago, LLC and World Imports South LLC (“World Imports”) and OEC Group New York (“OEC”) hereby jointly move to hold the case in abeyance pending entry of a World Imports Plan of Reorganization.

The parties to this action have reached an agreement in principle to settle this and related litigation. The terms of the settlement are to be reflected in a Plan of Reorganization to be submitted by World Imports in its bankruptcy action before the Bankruptcy Court for the Eastern District of Pennsylvania. Upon confirmation of a Plan of Reorganization containing the terms agreed to by World Imports and OEC, this action will be dismissed with prejudice by World Imports.

The parties anticipate that it will take approximately 75-90 days to obtain approval of the proposed Plan of Reorganization.

Whereby the parties jointly request that the case be held in abeyance so as to allow the disputes between the parties to be resolved.
